TO REGISTER:

1. Print form and cut along dotted line.
2. Sign form and mail with appropriate fees to address shown.
3. Under normal circumstances you should receive your registration card within 3 weeks. Please make copies of your card immediately after you receive it, as you will need copies for meet entries, clinics and some workouts to prove your registration. Note your card is also proof of your USMS liability insurance.
4. Replacement cards are \$5.

ADDITIONAL NOTES:

1. Your USMS Registration will be valid from the date of registration through 12/31/2012.
2. If you register between September 1, 2012 and October 20, 2012 the fee is reduced to \$42.
3. The donations to the two foundations are tax deductible.
4. Upon your registration you will receive three publications: The Swimmer's Ear, Swimmer magazine and The Rime:
 - The Swimmer's Ear is a newsletter published by the Potomac Valley LMSC. It contains local meet announcements plus articles submitted by our members. The Swimmer's Ear is published 3-4 times per year. If you do not want to receive this newsletter, (e.g. there are multiple registered PV swimmers at your residence) please include a note with your registration.
 - Swimmer magazine is published every two months. Your subscription will be valid through the 2013 Jan/Feb issue (please note there may be a delay of up to 2 months for your magazine subscription if a printing deadline has passed). You may opt out of receiving the magazine but you may not elect to receive credit in lieu of the subscription.
 - The Rime is the Ancient Mariner team newsletter and it is usually published three times each year.
